#### **Programs**

#### North American Practitioner Program

Our program presents the core teachings and lectures of Professor George Vithoulkas, where he shares his knowledge gained from over 60 years of experience. This program is based on the highest educational standards according to the principles of Samuel Hahnemann M.D., and is the only homeopathy course adopted as a Postgraduate Course by several medical universities from around the world.

- A total of over 1000 hours are included in this course, which includes a minimum of 500 foundational/classroom hours in classical homeopathy, and 10 Supervised Clinical requirements up to 360 hours of observation and analysis and a minimum of 140 hours (documentation of 10 chronic cases independently taken and written up with two follow-ups each) supervised by a CCH certified or BHMS supervisor.

#### **Courses in Alonissos**

Each year Professor Vithoulkas teaches a number of seminars throughout the summer months for current and postgraduate students to attend live at the International Academy of Classical Homeopathy in Alonissos Greece.

All students and alumni are encouraged to attend. The Courses are intended to illustrate the correct application and thought process during case-taking, and how a proper analysis and process of evaluating symptoms and their synthesis can result in the accurate homeopathic remedy - the similimum.

#### **E-Learning for International Students**

Our two-year E-Learning program –which is accredited by several international medical universities – is available to students residing <u>outside</u> of North America who do not want to attend the course in the expanded format. The course includes Theory, Levels of Health, Materia Medica, Repertorization, and case studies. In 1980, George Vithoulkas was invited by the **World Health Organization** to write the first article on homeopathy for the book, Traditional Medicine, published by WHO, as well as the main article in the round table discussion for WHO's scientific magazine, the World Health Forum [3] journal.

On the 11<sup>th</sup> of June, 1999, George Vithoulkas was requested by the **Council of Europe** to make a day-long presentation on homeopathic medicine (as part of their evaluation of alternative therapeutic methods) before the Social, Health and Family Affairs Committee.

In 1996, he was invited by the **European Parliament** to explain the position of homeopathy and after his presentation the European Parliament voted in favour for Homeopathy.

#### INTERNATIONAL ACADEMY OF CLASSICAL HOMEOPATHY

In 1995, Prof. George Vithoulkas established the **International Academy of Classical Homeopathy** in Alonissos, Greece, where he serves as Head of Educational Department

(Educator). In this Academy, George Vithoulkas shares the knowledge gleaned from his 60 years of his experience and teaches his most current theories regarding levels of health. In his teachings, he provides detailed information that both helps doctors determine each patient's state of health, as well as facilitates their ability to estimate whether a case is curable with homeopathy and the amount of time and remedies that will be needed to accomplish a cure.

Every year, during the summer months, groups of doctors from various countries gather to be trained at the Academy. These countries include Germany, Italy, Sweden, Norway, the United Kingdom, Russia, U.S.A., Canada, Austria, Japan, India, Pakistan, Mexico, Brazil, Peru, Greece etc.

#### Admissions

#### **Prerequisites**

We invite students to join our program from all different areas of expertise and study. An associate or graduate degree is preferred but not required. Students who have not taken Anatomy and Physiology and Pathology classes prior to taking our program need to also complete these prerequisites prior to finishing the 3-year program in order to obtain their diploma from IACH. In order to assist students in acquiring these prerequisites, we have aligned our school with another external program in order that students also receive a discounted tuition rate. #### **Procedures**

Following are the requirements for student applications:

- A completed application form as well as a curriculum vitae or resume is required for consideration of inclusion to our program.
- Two letters of recommendation are also required. At least one of these should be a
  professional reference from a homeopathic practitioner, professional in the
  healthcare industry, or a colleague/superior from the applicant's current
  profession.
- Additional requirements include proof of identification such as Driver's License, or Passport to be provided with IACH application.
- Applicants must obtain a background check on themselves from the criminal records office at their local police department. In order to obtain this form, most

police departments require applicants to fill out a form at the station. A driver's license, passport or other legal form of ID must be presented. There is usually a fee for this service, which varies from state to state and city to city, but it is usually between \$5 and \$10. Once the applicant submits the form, it usually takes 5–10 business days before the authorities send the applicant notification that the report is available for pick up. A background check must be included with all application submission.

The deadline for registration is July 31, 2023. Applications and required documentation must be received in our office by July 31, 2023. All emailed documents must be attached as a Word .doc or in pdf format. Once we receive an application and all required documentation, applicants are contacted via email in order to set up an interview for final entrant consideration.

Furthermore, in compliance with state and federal laws, The International Academy of Classical Homeopathy does not discriminate on the basis of race, religion, color, national origin, age, sex, veteran status, sexual orientation, marital status or disability, in any of its educational programs.

#### **Advanced Placement**

Advanced placement into the three-year program is not permitted – regardless of previous education, credits, or diploma. Students are not permitted to "test in" at an advanced level or bypass their first or second years of training in the program. Students with prior training in homeopathy are not permitted to skip select classes, segments, semesters or course portions which may contain some material that they are familiar with. Credits from other schools of homeopathy are not accepted as our program and level of education is unique in its immersion methodology. However, a 50% discount on tuition is granted to those who have already obtained CHC certification or have previously attended the 2-year or 3-year program at IACH.

#### **Diploma and Credentials**

Requirements to Obtain Diploma:

In order to receive the IACH Diploma, students are required to complete all the graduation requirements within a maximum period of 18 months from the completion of the program. The graduation requirements include: completion of the entire 3-year program, attendance adherence for class lectures and clinical studies, satisfactory academic performance, a passing grade on the final exam, completion of 10 supervised cases including approval in the Vithoulkas Portal, completion of Strategies in Prescribing II module, and completion of A&P course.

#### Diploma:

Once students have completed all of the program prerequisites listed above, maintained a GPA of 2.0 (on 4.0 scale), completed the course hours with a minimum attendance rate of 80%, maintained an overall average of 70% in the course and passed the final exams, students will receive an IACH Diploma for having satisfied the course requirements. The students who do not complete their supervised cases within 12 months from the time they first take the final exams, will be required to pay three hundred euros (300,00€) for an extension of up to six (6) months of access to the Vithoulkas Platform. If the graduation requirements are not complete within this period of eighteen (18) months after the completion of the course, the access to the Vithoulkas Platform will be terminated and the student will receive a Certificate of Attendance.

#### IACH DIHom:

Once students have received their diploma from the International Academy of Classical Homeopathy, they are entitled to use the credentials "IACH DIHom" (Diploma in Homeopathy from IACH) after their name. i.e. Jane Doe, IACH DIHom. This credential does NOT guarantee the right to legally practice in the student's state/country of residency, as students must adhere to the laws of their own respective local, state and national government.

#### **Technical Requirements**

#### **Tuition, Payment Details & Refund Policy**

Program cost for the total 3-Year North American Practitioner Program, and payment options:

The tuition for the entire 3-year Practitioner Program is \$12,000, plus clinic fee at \$275 per annum, and a nonrefundable \$50 registration fee, for a grand total of \$12,875.

\*NOTE: Current CHC holders and also those who have previously graduated and received a diploma from IACH receive a 50% discount on tuition for the upcoming year.

Normally, the tuition in full is payable prior to beginning the program. However, students may make payments on request for the following payment schedules:

- An annual payment may be made of \$4,000 prior to each new commencing year (no interest or financial penalty)
- Semester payments of \$1,333.33 may be made 3 weeks prior to each semester (3 payments per year for 3 years, with no interest or financial penalty)

A student who chooses to withdraw from the program after the commencement of classes is to provide written notice to the Program Coordinator. #### **Conduct, Rules and Regulations:**

Students are expected to behave in a respectful manner to their instructor(s) and peers and should not disrupt the class. The International Academy of Classical Homeopathy reserves the right to dismiss any student for conduct that is not becoming of an IACH student as outlined in the student handbook.

#### Attendance & Late Policy:

As this course and each class is uniquely and heavily saturated in case taking, patient intake, case analysis, and clinical training, we do not record classes in accordance with HIPAA regulations. A strict 80% attendance policy in our distance learning classroom is strongly enforced in order that students may acquire the highest level of education and training. Attendance counts as 10% of the grade for each semester. On Camera Requirement Students are required to have their webcams on during class.

#### Absence/Leave of Absence

Students are responsible to obtain missed class notes from peers. Notes are provided for all remedies and most of the theory sessions.

Students who must withdraw due to unforeseen circumstances and require leave of absence may join again in the following year during the same semester that they withdrew from previously. Students are not issued a refund for a semester they have partially or fully attended.

#### Homework

Homework is assigned weekly or twice per week, depending on the number of classes per week. Submission requirements are explained during orientation, and are also expressed in the Student Handbook for enrolled students to reference.

#### **Expectations and Course Grading System**

Homework accounts for 10% of the student's semester grade. Students must turn in their completed homework before the due date in order to receive credit. Failure to turn in an assignment prior to the deadline for submission will result in a 0% for the assignment.

Any student who neglects their course work may be issued a formal warning by IACH faculty. The warning will include detailed information regarding the area(s) in need of improvement, and any changes the student must make in order to comply with requirements. Students who continue to fall below the academic expectations of IACH faculty after issuance of a formal warning may be excluded from the course. Exclusion from the course is equivalent to failure in the course. A – (90% –100%) Excellent – This indicates full understanding and mastery of the material and distinctive commitment to course work and participation required.

B – (80% – 89%) Good – This indicates an exceptional understanding of the course material and an acceptable level of comprehension in regard to course material and engagement with the course requirements and activities.

C – (70% – 79%) Satisfactory – This indicates an acceptable level of comprehension and adequate comprehension of the course material as the student has met the most basic requirements for completing assigned work and participating in class activities.

D – (65% -69%) Unsatisfactory. This indicates some minimal effort has been made in regard to the course materials and some minimal participation in class activities merits some credit.

F - (0% - 64%) Failure to make an effort or participate

\* In addition to these requirements, in order to graduate from the course, students must also **submit 10 clinical cases complete with intake and at least 2 follow-ups**. Students must follow each of the 10 cases for a period of at least six months. (Please see the section on supervised cases.)

#### **Early Withdrawal**

A student choosing to withdraw from the program after the commencement of classes must provide written notice to the Program Coordinator. The notice is to indicate the expected date of withdrawal and be signed and dated by the student.
